THE SPECIAL SESSION OF COMMISSIONERS' COURT OF TRINITY COUNTY WAS HELD THURSDAY, SEPTEMBER 3, 2009 AT 10:00AM IN THE COMMISSIONERS' COURTROOM, TRINITY COUNTY COURTHOUSE ANNEX, GROVETON, TEXAS, WITH THE FOLLOWING MEMBERS PRESENT:

1. JUDGE EVANS CALLED THE MEETING TO ORDER AT 10:05AM, WELCOMED EVERYONE TO THE MEETING AND NOTED THAT THE AGENDA WAS PROPERLY FILED AND POSTED. AGENDA WAS FILED AUGUST 31, 2009 AT 8:10AM. ALL COMMISSIONERS WERE PRESENT. OTHER OFFICIALS PRESENT INCLUDED COUNTY AUDITOR SHEILA JOHNSON, AND COUNTY SHERIFF RALPH MONTEMAYOR.

2. AT 10:08AM A PUBLIC HEARING WAS OPENED ON A PROPOSAL TO INCREASE TOTAL TAX REVENUES FROM PROPERTIES ON THE TAX ROLL IN THE PRECEDING TAX YEAR BY 10.1%. ADDRESSING THE COURT WAS OSCAR BIERMAN. HE STATED THAT AT THIS TIME HE WAS NEITHER FOR OR AGAINST THE INCREASE BUT HAD QUESTIONS ABOUT SALARIES, INDIGENT HEALTH CARE COSTS, U. S. FOREST MONEY FOR ROAD AND BRIDGE AND EFFECTIVE TAX RATES. NO OTHER PERSONS WERE PRESENT FOR PUBLIC COMMENT. THE PUBLIC HEARING WAS CLOSED AT 10:25AM.

3. WITH NO FURTHER MATTERS TO COME BEFORE THE COMMISSIONERS' COURT ON A MOTION FROM COMMISSIONER WORSHAM AND SECONDED BY COMMISSIONER HORTMAN, COURT WAS ADJOURNED AT 10:27AM. MOTION CARRIED.
