




2. BOB BASS, ALLISON & BASS LAW FIRM, AUSTIN WAS PRESENT AND EXPLAINED IMPLEMENTATION OF HB1117 (COUNTY ROAD MAP) TO COMMISSIONERS' COURT, REVIEWED TIME SCHEDULE AND PROTEST PROCEDURES. MR. BASS THEN HELD A WORKSHOP ON CHANGES TO COUNTY ROAD MAP WITH COMMISSIONERS, ADDRESSING EACH PRECINCT INDIVIDUALLY AND ANSWERING QUESTIONS. HE ANNOUNCED THAT HE WOULD BE SENDING AN UPDATED MAP TO COMMISSIONERS AFTER CHANGES WERE IMPLEMENTED. NO OFFICIAL ACTION WAS TAKEN BY COMMISSIONERS ON THIS ITEM.
