THE SPECIAL SESSION OF COMMISSIONERS' COURT OF TRINITY COUNTY WAS HELD WEDNESDAY, JUNE 30, 2010 AT 10:00AM IN THE COMMISSIONERS' COURTROOM, 219 WEST FIRST STREET, TRINITY COUNTY COURTHOUSE ANNEX, GROVETON, TEXAS WITH THE FOLLOWING MEMBERS PRESENT:

1. JUDGE EVANS CALLED THE MEETING TO ORDER AT 10:00AM AND NOTED THE AGENDA WAS PROPERLY FILED AND POSTED AT 11:15AM JUNE 25, 2010 AT 11:15AM. ALL COMMISSIONERS WERE PRESENT.
