2. RENEWAL OF COUNTY HEALTH AND EMPLOYEE BENEFITS COVERAGE 1300 PLAN WITH THE TEXAS ASSOCIATION OF COUNTIES HEALTH AND EMPLOYEE BENEFITS POOL REFLECTING A 9% INCREASE OF PREMIUMS WAS MADE BY A MOTION FROM COMMISSIONER WORSHAM AND SECONDED BY COMMISSIONER HORTMAN. MOTION CARRIED.

3. A BUDGET WORKSHOP WAS HELD ON PREPARATION OF THE FY2011 TRINITY COUNTY BUDGET. ITEMS REVIEWED AND DISCUSSED BY COMMISSIONERS INCLUDED EQUAL PAY FOR ALL FOUR CONSTABLES, JP REVENUE, PROPERTY INSURANCE COVERAGE, WORKERS' COMPENSATION INSURANCE, CONTRACT JAIL SPACE, APPRAISAL DISTRICT PROPOSED BUDGET AND COUNTY ROAD MAP. NO OFFICIAL ACTION WAS TAKEN BY COMMISSIONERS ON THIS ITEM.
