

THE SPECIAL SESSION OF COMMISSIONERS' COURT OF TRINITY COUNTY WAS HELD THURSDAY, SEPTEMBER 24, 2010 AT 9:00AM IN THE COMMISSIONERS' COURTROOM, TRINITY COUNTY COURTHOUSE AUXILIARY COURTHOUSE, 218 WEST FIRST STREET, GROVETON, TEXAS, WITH THE FOLLOWING MEMBERS PRESENT:

1. JUDGE EVANS CALLED THE MEETING TO ORDER AT 9:00AM, WELCOMED EVERYONE TO THE MEETING AND NOTED THAT THE AGENDA WAS PROPERLY FILED AND POSTED. AGENDA WAS FILED 9-20-10 AT 3:35PM. ALL COMMISSIONERS WERE PRESENT. OTHER OFFICIALS PRESENT INCLUDED COUNTY AUDITOR SHEILA JOHNSON AND COUNTY CLERK DIANE MCCRORY.

2. JUDGE EVANS OPENED A PUBLIC HEARING ON THE PROPOSED FY2011 TRINITY COUNTY BUDGET AT 9:05AM. ADDRESSING THE COURT OPPOSING THE BUDGET AS PRESENTED WERE LYN HILL – CHITA COMMUNITY, JOE TEER – HARBOR POINT SUBDIVISION, HAMP BURWICK – CHITA COMMUNITY, LINDA SAMPLE – CHITA COMMUNITY, CHARLES AINSWORTH – CITY OF TRINITY, STANLEY HOLDER – HARBOR POINT SUBDIVISION, AND GEORGE WHITTLESEY – CITY OF GROVETON. WITH NO FURTHER PUBLIC COMMENT, THE PUBLIC HEARING WAS CLOSED AT 9:37AM.

3. APPROVAL OF THE FY2011 TRINITY COUNTY BUDGET WAS MADE BY A MOTION FROM COMMISSIONER WEBB AND SECONDED BY COMMISSIONER HORTMAN. MOTION CARRIED UNANIMOUSLY BY ALL FIVE MEMBERS OF COMMISSIONERS' COURT.

4. COMMISSIONER WORSHAM MADE THE MOTION THAT THE PROPERTY TAX RATE BE INCREASED BY THE ADOPTION OF A TAX RATE OF \$.65, WHICH IS EFFECTIVELY A 17.41% INCREASE IN THE TAX REVENUE. COMMISSIONER BROWN SECONDED THE MOTION. MOTION CARRIED.

5. APPROVAL OF THE 2010 TAX YEAR CERTIFIED TAX ROLL WAS MADE BY A MOTION FROM COMMISSIONER WEBB AND SECONDED BY COMMISSIONER HORTMAN. MOTION CARRIED.

6. APPROVAL OF AN ORDER ADOPTING THE TAX RATE FOR THE 2010 TAX YEAR AND FY2011 TRINITY COUNTY BUDGET WAS MADE BY A MOTION FROM COMMISSIONER WORSHAM AND SECONDED BY COMMISSIONER WEBB. MOTION CARRIED.

7. WITH NO FURTHER BUSINESS TO COME BEFORE THE COURT, ON A MOTION FROM COMMISSIONER WORSHAM AND SECONDED BY COMMISSIONER HORTMAN, COURT WAS ADJOURNED AT 9:42AM. MOTION CARRIED.
