1. JUDGE PAGE CALLED THE MEETING TO ORDER AT 9:00AM, WELCOMED EVERYONE TO THE MEETING AND NOTED THAT THE AGENDA WAS PROPERLY FILED AND POSTED. AGENDA WAS FILED 8-30-11 AT 8:40AM. ALL COMMISSIONERS WERE PRESENT. OTHER OFFICIALS PRESENT INCLUDED SHERIFF RALPH MONTEMAYOR, COUNTY AUDITOR SHEILA JOHNSON, COUNTY ATTORNEY JOE WARNER BELL, JP#1 RANDY BARRETT AND COUNTY CLERK DIANE MCCRORY.
2. AT 9:10AM A PUBLIC HEARING WAS OPENED TO DISCUSS REDISTRICTING COMMISSIONERS PRECINCTS AND VOTING PRECINCTS. NO ONE FROM THE PUBLIC WAS PRESENT FOR COMMENT. THE PUBLIC HEARING WAS CLOSED AT 9:20AM.
3. ACTION ON REDISTRICTING COMMISSIONERS PRECINCTS AND VOTING PRECINCTS WAS PASSED UNTIL THE 9-12-11 REGULAR SESSION OF COMMISSIONERS' COURT.
4. JP#1 RANDY BARRETT ADDRESSED THE COMMISSIONERS' COURT REGARDING TRUANCY MATTERS HANDLED BY HIS OFFICE AND COSTS OF FILING TRUANCY MATTERS FOR ALL THE SCHOOLS IN TRINITY COUNTY. JUDGE BARRETT WAS ADVISED TO DISCUSS THE SITUATION WITH THE CITY OF TRINITY AND T.I.S.D. ADOPTION OF FY 2012 PROPOSED TRINITY COUNTY BUDGET WAS MADE BY A MOTION FROM COMMISSIONER WORSHAM AND SECONDED BY COMMISSIONER BROWN. MOTION CARRIED.
5. HEARINGS WERE SET FOR ADOPTION OF THE TAX RATE FOR TRINITY COUNTY FY 2012 ON 9-21-2011 AND 9-26-2011 WITH A FINAL MEETING OF 9-30-2011 BY A MOTION FROM COMMISSIONER WEBB AND SECONDED BY COMMISSIONER WORSHAM. MOTION CARRIED.
6. WITH NO FURTHER BUSINESS TO COME BEFORE COMMISSIONERS' COURT, ON A MOTION FROM COMMISSIONER WEBB, SECONDED BY COMMISSIONER WORSHAM, COURT WAS ADJOURNED AT 10:00AM. MOTION CARRIED.
