

PUBLIC HEARING

A PUBLIC HEARING WAS HELD FRIDAY, JANUARY 7, 2011 AT 10:00AM IN THE COMMISSIONERS' COURTROOM, TRINITY COUNTY COURTHOUSE AUXILIARY COURTHOUSE, 218 WEST FIRST STREET, GROVETON, TEXAS, WITH THE FOLLOWING MEMBERS PRESENT:

JUDGE PAGE OPENED THE PUBLIC HEARING AT 10:05AM AND INTRODUCED BOB BASS, ATTORNEY WITH ALLISON, BASS & ASSOCIATES. MR. BASS GAVE THE COMMISSIONERS AND PERSONS ATTENDING AN OVERVIEW OF THE PURPOSE OF THE COUNTY ROAD MAP. ADDRESSING THE COURT WITH CONCERNS ABOUT THE COUNTY ROAD MAP WERE DWIGHT PYLE, AMIE KING, GEORGE WHITTLESEY AND JOHN WAYNE REYNOLDS. THE MATTER OF JOHN THOMPSON ROAD AND DRISKELL-MCLAUGHLIN ROAD BROUGHT FORWARD BY GEORGE WHITTLESEY WILL BE REFERRED TO A JURY TO DETERMINE WHETHER THE ROADS ARE COUNTY ROADS OR PRIVATE ROADS. OTHER DETERMINATIONS WERE HANDLED BY COMMISSIONERS AND MR. BASS, WITH THE EXCEPTION OF ROY TIPTON ROAD WHICH WOULD BE A DETERMINATION OF THE DISTRICT COURT. MR. BASS EXPLAINED THAT HE WOULD PREPARE A SUMMARY, THE JURY WOULD MEET IN 30-60 DAYS AND THE COUNTY ROAD MAP WOULD BE AVAILABLE FOR ADOPTION WITHIN 90 DAYS. WITH NO FURTHER PUBLIC COMMENT, THE HEARING WAS CLOSED AT 11:55AM.
