Contractor shall mask off and site-protect all areas not being painted and post "Wet Paint" signs. The Contractor shall mask and carefully paint around any door hardware, windows, doors, window bars and non-removable fixtures. All work shall be performed in accordance with manufacturer's written instructions and specifications.
