## **ANNUAL BUDGET**

**October 1, 2018 – September 30, 2019**

The information on this cover complies with the requirements of S.B. 656 of the 83<sup>rd</sup> Legislative Session, amending Local Gov't Code Sec. 111.008-111.009

This budget will raise more revenue from property taxes than last year's budget by an amount of \$162,258 which is a 3.4 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$110,456.48.
