THE SPECIAL SESSION OF COMMISSIONERS' COURT OF TRINITY COUNTY WAS HELD FRIDAY, SEPTEMBER 15, 2017 AT 9:00 A.M. IN THE COMMISSIONERS' COURTROOM, 162 WEST 1ST STREET, TRINITY COUNTY COURTHOUSE, GROVETON, TEXAS, WITH THE FOLLOWING MEMBERS PRESENT:

3. CONDUCT A PUBLIC HEARING ON ADOPTION OF FY 2018 BUDGET. HEARING OPENED @ 9:03 A.M. CLOSED @ 9:10 A.M.
4. APPROVAL OF ADOPTING THE FY 2018 BUDGET, EXCLUDING CHANGES PRESENTED IN MEMO IN REGARDS TO EMERGENCY MANAGEMENT/ENVIRONMENTAL ENFORCEMENT, WAS MADE BY A MOTION FROM COMMISSIONER BROWN AND SECONDED BY COMMISSIONER SMITH. MOTION CARRIED.
