

The regular session of Commissioners' Court of Trinity County was held Tuesday, March 27, 2018 at 9:00 am in the Commissioners' Courtroom, 162 west 1st street, Trinity County Courthouse, Groveton, Texas, with the following members present:

1. Judge Page called the meeting to order at 9:00 am and noted that the agenda was properly filed and posted at 3:30 P.M., March 22, 2018. All Commissioners were present, other officials' present included Trinity County Auditor Bonnie Kennedy, Treasurer Bob Dockens, Constable Pct. 1 Tommy Park, Constable Pct. 2 Mark Cole and County Clerk Shasta Bergman; Commissioner Worsham welcomed everyone to the meeting.
2. Johnathan Davison led the group in an opening prayer. Judge Page led the group in the Pledge of Allegiance to the American and Texas flags.
3. Present for the public forum Crystal Lyons and Rebecca Statncki inquired about the possible adoption of Reggie Lane by Trinity County Commissioners.
4. Approval of the minutes of the March 13, 2018 Regular Session and March 20, 2018 Special Session was made by a motion from Commissioner Smith and seconded by Commissioner Brown. Motion carried.
5. Approval of Official Bond for Crystal Due, Deputy County Clerk, was made by a motion from Commissioner Worsham and seconded by Commissioner Smith. Motion carried.
6. Discuss and Act on Pauper Funeral Payment. None presented.
7. Discuss and Act on Proclamation declaring the Month of April as Child Abuse Prevention Month in Trinity County. No action was taken on this item.

Motion carried.

15. Approval of correcting the name on road signs and the Trinity County Road Map from Benny Lee Rd to B Lee Rd, a county-maintained road in Precinct #4 was made by a motion from Commissioner Brown and seconded by Commissioner Smith. Motion carried.
16. Approval of correcting the name on road signs and the Trinity County Road Map from J Bailey Rd to Joe Bailey Rd, a county-maintained road in Precinct #4 was made by a motion from Commissioner Brown and seconded by Commissioner Smith. Motion carried.

Approval of correcting the 911 addressing map to reflect the correct location of Sweetwater Ln and Ratcliff St, private roads located in Lake L Acres in Precinct 2, which were inadvertently placed on the map opposite of where they should have been placed was made by a motion from Commissioner Brown and seconded by Commissioner Smith.
