Trinity County is giving notice of the County's intent to submit a GLO Community Development Block Grant Program MOD Application(s) to assist the community with Mitigation efforts through an Emergency Shelter as a Countywide benefit. The anticipated cost is \$5,250,000.

## Trinity County Project Description

The proposed project for Trinity County consists of the design and construction of a community shelter facility intended to provide a safe and functional gathering space during emergency events and community use activities. The facility will include an open multipurpose room, restroom facilities, a commercial-style kitchen area, and a covered porch area to support both emergency operations and day-to-day public functions.

In addition to the building improvements, the project will include supporting site infrastructure necessary for full operation of the facility. Site improvements will consist of parking areas, sidewalks and accessible pedestrian connections, waterline extension and utility connections, and installation of an on-site septic system. The proposed improvements are intended to enhance public safety, increase emergency preparedness capabilities, and provide resilient community infrastructure for residents of Trinity County.
