1. Purpose

Trinity County Road & Bridge Precincts 1 -4 is soliciting proposals from qualified vendors to perform precise remeasurement of all County-maintained precinct roads. The goal is to obtain accurate length measurements (in linear feet or miles) for recordkeeping, maintenance planning, and funding purposes.

2. Scope of Work

- Measurement Type: Length only; no width measurements are required.

- Roads Included: All County-maintained roads within each Precinct.

- Approximate location of property boundaries can be found on Trinity County's website at <u>https://www.co.trinity.tx.us/page/trinity.911Addressing</u>. Any additions or deletions to existing County-maintained roads are available from the Trinity County GIS and 911 Addressing Office.

- Endpoint Determination:

- When existing maps are unclear on the termination point of County responsibility, the Precinct Commissioner shall determine the end of the road.

- The vendor must coordinate with each Precinct Commissioner as necessary to confirm endpoint decisions.

- - Final Deliverables:
 - Comprehensive list of measured roads by precinct.
 - Each road entry must include:
 - Road name
 - Precinct number
 - Start and end point description (including GPS coordinates)
 - Total measured length
 - Data must be delivered in Microsoft Excel (.xlsx) format.

3. Proposal Requirements

All proposals must include the following:

- Company background and relevant experience
- Methodology and tools to be used for measurement
- Timeline for completion of the project
- Itemized cost estimate
- Names and qualifications of key personnel
- References from similar projects (preferably for counties or municipalities)

4. Proposal Submission

<u>One Original and four copies</u> of the proposal, including all required forms and applicable supporting documentation, are required. The original must be clearly marked "ORIGINAL" and the copies must be clearly marked "COPY". Submit completed proposals in a sealed envelope clearly marked: "RFP – Road Remeasurement Project" and deliver to:

5. Evaluation Criteria

Proposals will be evaluated based on:

- Experience and qualifications (25%)
- Methodology and approach (25%)
- Cost (25%)
- Timeline and availability (15%)
- References and past performance (10%)
